MEMORANDUM

②

1. NAME :-

The name of the Society shall be " DARSHAN EDUCATION FOUNDATION " .

2. REGISTERED OFFICE :-

The Registered Office of the Society shall be in the Union Territory of Delhi and the same is now situated at Kirpal Ashram, 2 Canal Road, Vijay Nagar, Delhi - 110 009. However, the Society shall work for its Aims and Objects all over India generally.

3. AIMS AND OBJECTS :-

The Society shall carry on its work for Educational, Spiritual, Ethical, Scientific, Literary, Charitable, and Cultural purposes for the benefit of mankind at large and shall have, inter alia, following Aims & Objects :-

- i. To promote Simple Education, Moral Education, Technical Education, Scientific Education, Comparative study of Religion and Yoga, Unity of Man-kind and paving the way for understanding global cultures, in various ways and by various means of Communications including Oral, Written, Printed, Photographic, Audio-Visual material, Magazines, Books, Lithographics Illustrative designs, Animation, Prints in Original / Translated versions etc. ;
- ii. To distribute, issue, circulate and provide such materials to the general public at large ;
- iii. To establish and run Charitable Educational Institutions and impart or get imparted Basic, Nursery, Primary, Middle, Secondary, Senior Secondary and Higher Education in all disciplines and in all manners prevalent through out the Country or abroad, according to law.

iv. To collect, exchange, issue, grant, publish and / or acquire rights therefor various audio visual materials etc. from India and abroad, for moral education, comparative study of religion and yoga, promoting unity of mankind and paving the way for understanding global cultures ;

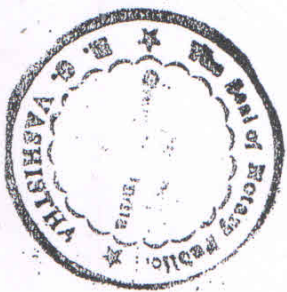
v. To propagate the principles of Yoga (Sant Mat) - the Science of Soul ;

vi. To use any funds of this Society for the promotion of the objects of the Society and no portion of it shall be paid to or distributed amongst the members of the Society ;

vii. To promote Spirituality as a Science of Soul and Art of Meditation and for the promotion of Science, Literature, the diffusion of useful knowledge, the maintenance of Audio Visual or Book Libraries and Reading Rooms for general use among the followers / disciples of truth and Sant Mat and to establish and to organise Seminars, Competitions, Conferences, Exhibitions and Congregations etc. therefor ;

viii. To do such other incidental acts, deeds and things that may become necessary while achieving the above objects of the Society ;

4. All the income, earnings, moveable, immoveable properties of the Society shall be solely utilised and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits, or in any manner whatsoever to the present or past Members of the Society. No present or past Member of the Society shall have any personal claim on any immoveable properties of the Society or make any profits, whatsoever, by virtue of his membership.

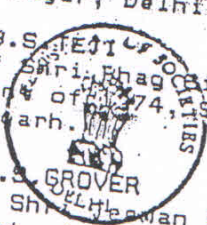

RULES AND REGULATIONS

1. NAME: The name of the Society shall be "DARSHAN EDUCATION FOUNDATION."

2. MEMBERSHIP:

(1) ELIGIBILITY:

The following conditions shall govern the eligibility for the Membership of the Society:-

(a) He/She should be an initiate of Hazur Baba Sawan Singh Ji Maharaj or His Holiness Param Sant Kirpal Singh Ji Maharaj or H.H. Param Sant Darshan Singh Ji Maharaj or Sant Rajinder Singh Ji Maharaj or His Successor(s);

(b) He/She should believe in the aims and objects of the society;

(c) He/She should be a pure vegetarian and teetotaler and must not be addicted to any form of intoxication;

(d) He/She should be moral, ethical and simple in life, be of sound personal character and shall be at least 18 years old;

(e) He/She must not have been convicted of any offence involving moral turpitude nor shall he be an insane or insolvent person;

(2) ENROLMENT:

I. The enrollment of a member of the society shall be made by a simple majority of the total members of the Managing Committee of the society in its Meeting when his/her name is proposed and seconded by two members of the Managing Committee of the Society one of whom should be the Chairman of the Society;

II. The Managing Committee has the exclusive right to admit or not to admit any person as a member of the society and the reasons of the rejection of the membership shall be communicated to the person concerned.

(3) REMOVAL OF MEMBERS:

I. The Managing Committee of the Society may remove any member of the society on the following grounds:-

(a) If the member works, in the opinion of the Chairman of the Society, against the aims and objects of the Society;

(b) If a member fails to attend three consecutive meetings of the General Body/Managing Committee;

(c) In the event of the member being convicted of any offence involving moral turpitude or becoming insane or insolvent;

(d) In the event of the member failing to or ceasing to comply with the eligibility conditions laid in Rule 2(1) hereinabove.

II. Any member upon his/her death or upon submitting a Resignation from the membership of the Managing Committee/General Body in writing addressed to Chairman, shall cease to be a member of the Society with effect from the date of death or with effect from the date of acceptance of his/her Resignation by the Chairman on the recommendations of the Managing Committee of the Society, as the case may be. The reasons for removal from membership shall be communicated to the person concerned.

3. GENERAL BODY.

There shall be a General Body of the Society consisting of all the members. The meetings of the General Body shall be held at least once a year. The quorum for all the meetings (including the adjourned meeting) shall be at least one third members of the General Body. The following business shall be conducted at the meetings of the General Body:-

(i) To prepare annual programmes and suggest policies for the society;

(ii) To discuss and decide any matter or issue relating to the affairs of the society referred to it by the Managing Committee of the Society with the prior permission of the Chairman of the Society;

(iii) To Elect the Managing Committee of the Society each year;

(iv) To suggest and advise the Managing Committee as to the ways and means for achieving the aims and objects of the society. However, such advice to the Managing Committee may not be mandatory.

4. MANAGING COMMITTEE

(1) CONSTITUTION

(i) There shall be a Managing Committee of the Society to look after and to manage the day to day affairs of the society. It shall consist of a minimum of Thirteen and a maximum of Twenty one members including the office bearers;

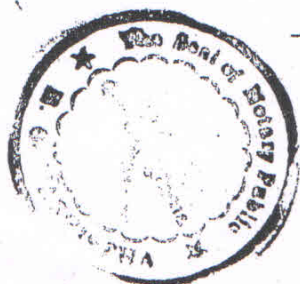
(2) MEETINGS: The meetings of the Managing Committee shall be called by the General Secretary at least once in every quarter (three months).

(3) QUORUM: The quorum of the meetings of the Managing Committee (including the adjourned meetings) shall be at least one-third Members of the Managing Committee.

(4) NOTICE: All Ordinary and Emergent Meetings of the General Body and Managing Committee/Governing Body of the Society may be held after giving a notice of atleast seven days;

(5) BUSINESS: The following business shall be transacted in the ordinary meetings of the Managing Committee:-

(a) To take necessary steps for the implementation of all the programmes and policies drawn up by the General Body;

- (b) To approve necessary expenditure to meet the day to day requirement of the society;
- (c) To take all steps necessary for the promotion and smooth functioning of the Society;
- (d) The Managing Committee may frame and/or amend, alter, delete, supersede bye-laws for discharging various functions of the society and to manage properties thereof and regarding rights and duties of its Office Bearers or for other purposes;
- (e) The Managing Committee shall constitute and appoint committees and sub-committees under its control to assist the Managing Committee for the achievement of the objects of the Society;
- (f) The Managing Committee shall appoint an auditor, who shall be a Chartered Accountant, who may annually audit the accounts of the society and may submit the report to the Managing Committee;
- (g) To decide the issue of entering into any Agreements or contracts for promoting the aims and objects of the society;
- (h) To appoint Governing Body and its Office Bearers, Principals, Managers, Chief Administrative Officers, Administrative Officers, Teachers, Lecturers and other temporary/Ad-hoc/Permanent Employees for its Schools/Educational Institutions and settle their Terms and Conditions of Service, Code of Conduct and to take Disciplinary Actions for such Appointees and all Employees and Pupils and to exercise all other administrative residuary powers in respect thereof.
- (i) The Managing Committee may amend, alter, delete, supersede Memorandum and/or Rules and Regulations of the Society;
- (j) Any other work with permission of the Chairman of the Society.

(6) **TENURE:** The tenure of the Managing Committee of the Society shall be one year.

(7) **ELECTION:** The General Body shall every year elect the Office Bearers and Members of the Managing Committee by a simple majority of votes by show of hands/secret ballot after his or her name has been proposed by any two members of the society as per Rule 2 hereinabove. The Managing Committee so elected may consist of:

- (i) Chairman;
- (ii) Vice-Chairman;
- (iii) General Secretary;
- (iv) Secretary;
- (v) Treasurer;
- (vi) Not more than sixteen members.

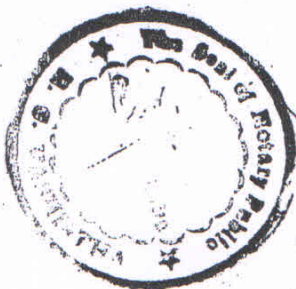
(8) Any Emergent or Extra-ordinary Meeting of the Managing Committee may be held on receipt of Joint written request for the holding of such a meeting from at least three-fifth of its total number of members or suo moto by the General Secretary for conduct of the business as aforesaid. 5. **OFFICE BEARERS AND THEIR DUTIES:** The Society may have the following Office Bearers:-

(iii) He is authorised to sign all documents on behalf of the society and to delegate these powers to any person in writing;

(2) VICE-CHAIRMAN:

In the absence of the Chairman, the Vice-Chairman may take up the Chair and may exercise the powers of the Chairman. However, his acts and/or orders will be subject to the confirmation in writing by the Chairman of the Society.

(3) GENERAL SECRETARY:

(i) He shall convene the meetings of the Managing Committee and General Body. Except in the case of an Emergent Meeting he shall give a notice of at least seven days and shall inform the members of the time, date, place and Agenda of the meetings. In case of an Emergent Meeting, the period of notice may be two days.

(ii) He shall keep all types of record of the Society with him in the Office of the Society including the Register of Members containing therein their names, addresses, etc., and all Members of the Society shall have access thereto with the permission of the Chairman.

(iii) He shall do all or any acts, deeds, and things as may be required by the Chairman/Managing Committee of the Society.

(4) SECRETARY:

In the absence of the General Secretary, the Secretary may look after his work.

(5) TRESURER:

He shall collect money, gifts, grants-in-aids, donations and other receipts from the members and general public in the name and on behalf of the society and shall maintain a true and accurate account of the funds of the society.

(6) **TENURE:** The tenure of the Managing Committee of the Society shall be one year.

(7) **ELECTION:** The General Body shall every year elect the Office Bearers and Members of the Managing Committee by a simple majority of votes by show of hands/secret ballot after his or her name has been proposed by any two members of the society as per Rule 2 hereinabove. The Managing Committee so elected may consist of:

- (i) Chairman;
- (ii) Vice-Chairman;

- (vi) Not more than sixteen members.

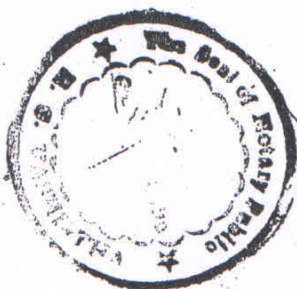

6. MANAGEMENT:

(1) The management of the affairs of the Society shall vest in the Managing Committee of the Society. The entire property and total assets of the society shall also vest in the Managing Committee along with the executive authority. The Managing Committee with the consent of the Chairman may delegate authority and powers to any person for the proper and smooth working of the society, and may withdraw such authority or powers without assigning any reason.

(2) The Managing Committee with more than two-third majority and with the consent of the Chairman may dispose of any property in the interest of the Society or may incur debt or liability on behalf of the Society.

7. MISCELLANEOUS RULES:

(1) The accounting year (financial year) of the society shall be from the first day of April of each English Calendar Month to the thirty first day of March of each succeeding year.

(2) Donations, fees, grants-in-aid, and gifts from members and the general public shall be amongst the sources of income of the Society. All the income of the Society shall be utilized for the achievement of aims and objects of the Society.

(3) The funds of the society shall be kept in a Scheduled Bank. The Bank Account shall be operated under the signature of the followings:-

- (A) Chairman or His Nominee with any one of the following:-
- (B) General Secretary, or
- (C) Treasurer.

The Chairman may delegate such powers to any Member of the Society.

(4) Once in every year, on or before the fourteenth day succeeding the day on which the Annual General Meeting of the Society is held, List of Names, Addresses, Occupations, and designations of the Members of the Managing Committee shall be sent to the Registrar of Societies;

(5) Whenever it shall appear to the Managing Committee of the Society, that it is advisable to alter, extend or abridge any particular purpose within the meaning of the Societies Registration Act, or to amalgamate the Society either wholly or partially with any other Society or Societies, the Managing Committee may submit the proposal to the members of the Society a written or printed report and may convene special meeting for the consideration thereof according to the Regulations of the Society, but no such proposal shall be carried into effect unless such report shall have been delivered or sent by post to every member of the society ten days previous to Special Meeting convened by the Managing Committee for consideration thereof, nor unless such proposal shall have been agreed to by the votes of more than three-fourth of the Members of the Managing Committee confirmed by the votes of more than three-fourth of the Members present at a second special Meeting convened by the Managing Committee at an interval of one month after the formal meeting.

(6) All the disputes or differences relating to the affairs and conduct of the business of the Society shall be referred to the Chairman whose decision shall be final and binding upon all parties and shall not be questioned in any manner in any forum in any circumstances except with his permission.

(7) Members, not less than three-fourth of the Managing Committee, may determine that it shall be dissolved forthwith, or at the time then agreed upon, and all necessary steps shall be taken for the disposal and settlement of the property or the society, its claims and liabilities according to the Rules of the Society applicable thereto, if any, and if not then as the Managing Committee shall find expedient, provided

that, in the event of any dispute arising among the said Managing Committee or the members of the Society, the adjustment of its affairs shall be referred to the principal Court of Original Civil Jurisdiction of the Delhi in which the chief building of the society is situated, and the court shall make such orders regarding matter as it shall deem requisite, provided that the Society shall not be dissolved unless three-fourth of the members shall have expressed a wish for such dissolution by their votes delivered in person or by proxy at a general meeting convened for the purpose.

(8) If upon the dissolution of the society there shall remain after the satisfaction of all the debts and liabilities any property whatsoever, the same shall not be paid, distributed amongst the members of the society or any of them, but shall be given to some other society to be determined by the votes of not less than three-fourth of the members present personally at the time of the dissolution in default thereof, by such court as aforesaid.

(9) The Society shall maintain its Books of Accounts at its Registered Office and its Branches all over India and shall get its Accounts audited each year from a reputed Chartered Accountant according to law.

(10) The Chairman of the Society shall be competent to fill up the casual vacancies on the cessation of membership of any member of the Society and such filling up of vacancies may be notified by the Society to the Registrar of Societies at Delhi according to law.

The Chairman may at his sole discretion, allow any member of the Society to be re-admitted to the Society on cessation of his/her membership provided he/she qualifies for its Membership as per above Rules and Regulations.

(11) The Society may sue or be sued in its own name through its General Secretary or any other person as determined by the Managing Committee of the Society as per provisions laid down under Section 6 of the Societies Registration Act, 1860, as made applicable to the Union Territory of Delhi.

AMENDED BYE-LAWS OF DARSHAN EDUCATION FOUNDATION

1. NAME: The name of the Society shall be "Darshan Education Foundation."

2. REGISTERED OFFICE: The Registered Office of the Society shall be in the Union Territory of Delhi and the same is now situated at Kirpal Ashram, 2, Canal Road, Vijay Nagar, Delhi-110 009. However, the Society shall work for its Aims and Objects all over India generally.

3. AIMS AND OBJECTS: The Society shall carry on its work for Educational, Social, Ethical, Scientific, Literary, Charitable, and Cultural purposes for the benefit of mankind at large and shall have, inter alia, following aims and objects:

i) To promote simple education, moral education, technical education, scientific education, comparative study of religion and yoga, unity of Society and paving the way for understanding global cultures, in various ways and by various means of communications, including oral, written, printed, photographic, Audio-visual material magazines, Books, Lithographics Illustrative designs, Animation, Prints in original, translated versions, etc.

ii) To distribute, issue circulate and provide such materials to the general public at large;

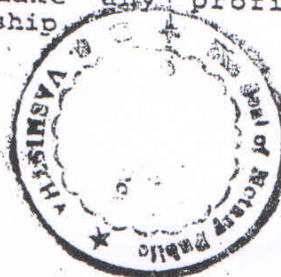

- iii) To establish and run Charitable Educational Institutions and impart or get imparted Basic, Nursery, Primary, middle, secondary, Senior Secondary and Higher Education in all disciplines and in all manners prevalent throughout the country or abroad, according to law.
- iv) To collect, exchange, issue, grant, publish and/or acquire rights therefor various audio visual materials, etc., from India and abroad, for moral education, comparative study of religion and yoga, promoting unity of mankind and paving the way for understanding global cultures;
- v) To propagate the principles of Surat Shabad Yoga (Sant Mat) The Science of the Soul;
- vi) To use any funds of this Society for the promotion of the objects of the Society and no portion thereof shall be paid to or distributed amongst the members of the Society;
- vii) To promote Spirituality as the Science of the Soul and Art of Meditation and for the promotion of Science, Literature, the arts and diffusion of useful knowledge, the management of Audio Visual or Book Libraries and Reading room for general use among the followers/ disciples of truth and Sant Mat and to establish and to organise Seminars, Competitions, Conferences Exhibitions and Congregations, etc., therefor;
- viii) To do such other incidental acts, deeds and things that may become necessary while achieving the above objects of the Society;

4. All the income, earnings, moveable, immoveable properties of the Society shall be solely utilised and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits, or in any manner whatsoever to the present or past members of the Society. No present or past Members of the Society shall have any personal claim on any immoveable properties of the Society or make any profits, whatsoever, by virtue of his membership.

5. (i) That the Registration of the Society will be got renewed, as and when required;
- (ii) That the Management Committee of Darshan Academy will have one nominee each from the Directorate of Education and Central Board of Secondary Education;
- (iii) That 10 percent of the seats in Darshan Academy will be reserved for brilliant, Scheduled Castes/ Scheduled Tribes, students and the School will not charge extra fees from the above said students than that prescribed by the Secondary Education Board or Basic Education Board of U.P. and as applicable to all other States and Union Territories of India;
- (iv) That Darshan Education Foundation will demand any grant-in-aid from the State Government of U.P. and as applicable to all other States and Union Territory of India; and if the school is earlier recognised with Secondary Education Board, and if the school gets affiliated with the Central Board of Secondary Education, New Delhi Council for the Indian School Certificate Examination, New Delhi, then the grant-in-aid from the State Government and the recognition with Secondary Education Board, will itself be cancelled, from the date of its affiliation, with the above Boards.
- (v) That the pay and other allowances of the teaching and non-teaching staff of Darshan Academy, Meerut, and that in all other States and Union Territory of India, will not be less than the prescribed pay scales and allowances paid to the employees of the U.P. State Government aided Educational Institutions and as applicable to all other States and Union Territories of India;
- (vi) That the school will frame service rules and regulations for its employees and they will be paid prescribed pensionary benefits equivalent to that paid to the employees of non-Government aided Senior Secondary Schools of U.P. and as applicable to all other States and Union Territories of India;

(vii) That the Orders and Notifications issued by the State Government, from time to time, will be complied with by the School;

(viii) That the school will maintain its record in the forms prescribed by the State Government. If yes, then a resolution of the Management Committee of Darshan Education Foundation in this respect that all the terms and conditions of Department/Government enumerated (from 1 to 8 of the form) are acceptable to the Management Committee of Darshan Academy.

(ix) That no addition/alterations/amendment will be made in the above conditions without the prior permission of the State Government.

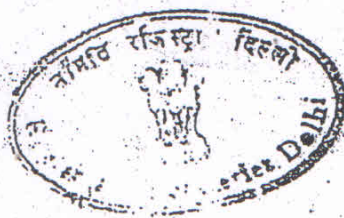
